On December 2, 1996, Microsoft Corporation (Microsoft) filed a Registration Statement on Form S-3, SEC 1933 Act Number 333-17143 (the Registration Statement), which was subsequently amended on December 13, 1996 and December 16, 1996, to cover \$862,500,000¹ of Microsoft's 2 $\frac{3}{4}$ % Convertible Exchangeable Principal-Protected Series A Preferred Shares (the Series A Shares²).

The Registration Statement was filed in order to register the Series A Shares, which were exchangeable, in certain defined circumstances, into convertible notes and/or shares of Microsoft Common Stock.

As all Series A Shares were converted to Microsoft Common Stock on December 15, 1999, Microsoft hereby de-registers all of its Series A Shares registered pursuant to the Registration Statement.

¹ Represents approximately 10,798,122 Series A Shares at a price, determined on December 18, 1996, to be \$79.875.

² Microsoft later filed amendments to the Registration Statement pursuant to Rule 462(b) covering an additional 1,564,946 Series A Shares (SEC Numbers 333-18055 and 333-18195).
