- (1) Effective November 14, 2008 and November 24, 2008, the reporting person does not have dispositive or voting authority, or otherwise have a beneficial interest, in 274,595 shares and 1,747 shares, respectively, of the Issuer's Common Stock.
- (2) On December 3, 2008, certain of the limited partnerships transferred 4,119,456 shares of the issuer's common stock to other limited partnerships and to accounts managed by RILLC, at a price of \$22.28 a share. This transaction did not change the overall beneficial ownership of the reporting person.
