Dividend equivalent rights accrue with respect to these PARSUs when and as dividends are paid on HP common stock.

(5) The share amounts reported reflect the conversion of the awards upon the distribution of the Hewlett Packard Enterprise shares on November 1, 2015.

(6) On 12/10/14 the reporting person was granted 95,484 restricted stock units ("RSUs"), 31,828 of which vested on 12/10/15, and 31,828 of which will vest on each of 12/10/16 and 12/10/17. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
