(1) This amended Form 4 corrects the 01/26/2017 grant of 4,287 restricted stock units and the 01/26/2017 grants of 12,860 and 4,287 performance units, respectively, that were mistakenly reported as having been awarded.

(2) As of 2/16/2017, the total restricted stock units beneficially owned is 21,482. This total includes the 01/22/2015 grant of 8,668 restricted stock units, 01/21/2016 grant of 8,478 restricted stock units and the 01/03/2017 grant of 4,336 restricted stock units.

(3) As of 02/16/2017, total performance units beneficially owned is 36,251.336.
