- (1) These sales were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person.

- (3) These shares are owned by the Stephen Trundle 2015 4 Year GRAT (the "4 Year GRAT"). The Reporting Person is the sole trustee and primary beneficiary of the 4 Year GRAT.
- (4) These shares are owned by Backbone Partners, LLC ("Backbone"). The Reporting Person has the sole power to vote and dispose of the shares held by Backbone. The Reporting Person disclaims beneficial ownership of the shares owned by Backbone except to the extent, if any, of his pecuniary interest therein.
- (5) Immediately exercisable.
- (6) This option is immediately exercisable. Twenty percent (20%) of the shares subject to this option vested on May 15, 2017 and the balance of the shares vest in a series of forty-eight (48) successive equal monthly installments beginning on June 1, 2017, subject to the Reporting Person's continuous service with the Company through each vesting date.
