- (2) Issuer on each respective vesting date. Of the quarterly vesting installments, 11 will vest an aggregate of 8,333 RSUs, and the 12th installment will vest an aggregate of 8,337 RSUs.

- The options vest in 12 quarterly installments over three years, commencing on October 1, 2018 and continuing thereafter on the first day
