**Sao Paulo, April 24, 2007** GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low-cost, low-fare airline, was awarded the Latin American Deal of the Year for its 2006 perpetual bond offering.
