*“We hereby inform that B3 will submit to the Listing Commission of the Advisory Chamber of Issuers and Offerors (“Listing Commission”), pursuant to item 4.2 (iii) of the Guidelines of the Issuer, as well as item 7.7 of the Listing Rules of Issuers and Admission to Trading Securities, considering the need to evaluate the adequacy of Gol’s profile to the Novo Mercado, in the context of the corporate reorganization disclosed by the Companies”.*
