On May 10, 2007, F. Gordon Bitter, age 64, informed the Plexus Board of Directors that he intends to retire as Chief Financial Officer of Plexus in 2007.

Also on May 10, 2007, the Board elected Ginger Jones as an executive officer of Plexus and named her as successor to Plexus' Chief Financial Officer position. Ms. Jones, age 42, joined Plexus as its Vice President-Finance in April 2007. Ms. Jones served as Vice President, Corporate Controller for five years at Banta Corporation.
