Act of 1934, as amended (the "Act"), the undersigned hereby amend their Schedule 13D Statement dated May 5, 2004, as amended by Amendment No. 1 dated June 8, 2004, as amended by Amendment No. 2 dated June 29, 2005, as amended by Amendment No. 3 dated February 6, 2006, as amended by Amendment No. 4 dated March 2, 2006, as amended by Amendment No. 5 dated August 7, 2006, as amended by Amendment No. 6 dated August 14, 2006 (the "Schedule 13D"), relating to the Common Stock, par value \$0.00025 per share (the "Stock"), of i2 Technologies, Inc. (the "Issuer"). Unless otherwise indicated, all defined terms used herein shall have the same meanings as those set forth in the Schedule 13D.

ITEM 4. PURPOSE OF THE TRANSACTION.

Item 4 is hereby amended and restated in its entirety as follows:

The Reporting Person (on behalf of R<sup>2</sup>) has named one of its investment professionals, Michael Simmons, to the Issuer's Board of Directors. As previously disclosed, the terms of the Reporting Person's Preferred Stock currently give the Reporting Person the right to elect two members of the Issuer's Board of Directors. The Reporting Person also intends to fill its second Board seat, and is actively seeking a suitable candidate.

The Reporting Person has moved to fill its Board seats now - both empty since December 2005 - because it believes that the Issuer should explore strategic options, including a possible outright sale of the Issuer or its assets, and desires to participate in this process. The Reporting Person believes that the Issuer is too small to survive on its own in today's environment and that the value of the Issuer's assets cannot be maximized while the Issuer remains independent. Indeed, the Issuer's recently announced revenue and earnings shortfalls, as well as the recent departures of both the Issuer's Chief Executive Officer and its Chief Customer Officer, have added urgency to the situation. The Reporting Person therefore believes that the Issuer should publicly announce and implement a strategic review and sale process with the utmost speed.

The Reporting Person continues to support management at this difficult time, and looks forward to a collaborative process where management, the Board, and shareholders have a voice in the process going forward.

Michael Simmons is a senior operating partner in the private equity group of Q Investments, a group of entities associated with the Reporting Person, and Chief Executive Officer of Q Investments' energy business. Prior to joining Q Investments in 2007, Mr. Simmons spent 20 years at General Electric, including serving as Chief Executive Officer of PII Pipeline Solutions. He held executive and operating leadership roles throughout the U.S. and Europe in GE's pension fund, real estate, finance, energy and oil and gas divisions.

Except as set forth in this Item 4, the Reporting Person has no present plans or proposals that relate to or that would result in any of the actions specified in clauses (a) through (j) of Item 4 of Schedule 13D.
