The reporting person becomes vested in one fourth of such shares on the first, second, third and fourth anniversaries of the date of grant.
- (2) All of these 3,309 shares of common stock, as disclosed in this filing and the prior filing, are subject to vesting restrictions as of January 12, 2007.
- (3) The reporting person indirectly owns these shares of common stock through the Overseas Shipholding Group, Inc. 2000 Employee Stock Purchase Plan.
