Sabby Management, LLC, a Delaware limited liability company, indirectly owns 4,511,897 shares of Common Stock because it serves as the investment manager of Sabby Healthcare Volatility Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies. Mr. Mintz indirectly owns 4,511,897 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
