Rio de Janeiro, August 26th, 2016 – Vale S.A. (Vale) informs that the results of the investigation requested to Cleary Gottlieb Steen & Hamilton LLP on the rupture of the Fundão Dam in Mariana will be disclosed on August 29th at 2:00 pm EDT (3:00 pm BRT) and it will be broadcasted live via webcast in English and Portuguese. Following the dam rupture, Samarco, along with Vale and BHP Billiton, Samarco's shareholders, hired Cleary Gottlieb Steen & Hamilton LLP to carry an external investigation into the cause of the dam rupture.
