These securities are traded in the U.S. and Canada. Their title in the U.S. is

"common stock" and in Canada is "ordinary shares." The title reported in this

Schedule 13G is the title used in the U.S. as listed on the New York Stock Exchange, Inc. (the "NYSE").

[2] One of the investment management contracts that relates to these securities provides that

the applicable FRI affiliate share investment power over the securities held in the

client's account with another unaffiliated entity. The issuer's securities held in such

account are less than 5% of the outstanding shares of the class. In addition, FRI does

not believe that such contract causes such client or unaffiliated entity to be part of a

group with FRI or any FRI affiliate within the meaning of Rule 13d 5 under the Act.
