Item 1.01 Entry into a Material Definitive Agreement.

On January 29, 2015, our Avis Budget Rental Car Funding (AESOP) LLC subsidiary issued \$650 million of asset-backed securities with a maturity of five years, comprised of \$535.4 million aggregate principal amount of 2.50% Rental Car Asset Backed Notes, Class A, \$79.9 million aggregate principal amount of 3.22% Rental Car Asset Backed notes, Class B, and \$34.7 million aggregate principal amount of 3.96% Rental Car Asset Backed Notes, Class C. The notes were issued under the Series 2015-1 Supplement dated January 29, 2015, between Avis Budget Rental Car Funding (AESOP) LLC and The Bank of New York Mellon Trust Company, N.A., as trustee and as Series 2015-1 Agent, to the Second Amended and Restated Base Indenture dated as of June 3, 2004.

The notes are secured under the Second Amended and Restated Base Indenture primarily by vehicles and other related assets. The foregoing summary is qualified in its entirety by reference to the full text of the Series 2015-1 Supplement, a copy of which is attached hereto as Exhibit 10.1 and which is incorporated by reference herein. A copy of the press release announcing the issuance of the notes is attached hereto as Exhibit 99.1 and is incorporated by reference herein.

Certain purchasers of the notes, and the trustee, and their respective affiliates, have performed and may in the future perform, various commercial banking, investment banking and other financial advisory services for Avis Budget Group, Inc. and its subsidiaries for which they have received, and will receive, customary fees and expenses.
