This Amendment No. 2 to Schedule 13G (this "Amendment No. 2") is being filed with respect to the common stock, par value \$0.01 per share (the "Common Stock"), of Motorcar Parts of America, Inc., a corporation formed under the laws of the State of New York (the "Company"), to amend the Schedule 13G filed on May 29, 2007 (as amended by Amendment No. 1 thereto filed on February 13, 2008, the "Schedule 13G"). This Amendment No. 2 is being filed to disclose that the Reporting Persons no longer beneficially own more than 5% of the Common Stock. Capitalized terms used herein and not otherwise defined have the meanings ascribed thereto in the Schedule 13G.
