(2) International N.V.'s common stock, par value Euro 0.01 per share. DKM PL is controlled by Donald Keith Mosing, in his capacity as its general partner and trustee of its other general partner, Donald Keith Mosing Revocable Trust.

(3) On August 14, 2013, the reporting person was granted 1,136,364 RSUs, vesting 20% per year on the anniversary of the grant over the first three years, with the remaining 40% vesting on March 31, 2017. This grant was accelerated and vested in full on July 1, 2016 pursuant to that certain Separation Agreement dated December 31, 2015, by and among Frank's International, LLC, Frank's International N.V. and Donald Keith Mosing.

(4) Also consists of 176,282 RSUs that will vest 50% on February 23, 2017 and 50% on February 23, 2018 and 10,060 RSUs that will vest in full on May 1, 2017.
