This Amendment No. 2 (the "Amendment") amends and supplements the Schedule 13D filed on February 4, 2013, as amended and supplemented by Amendment No. 1 filed on August 16, 2013 (as so amended, the "Original Schedule 13D" and, as further amended and supplemented by this Amendment, the "Schedule 13D") by TPG Group Holdings (SBS) Advisors, Inc. and Messrs. David Bonderman and James G. Coulter with respect to the Ordinary Shares of the Issuer. Capitalized terms used in this Amendment and not otherwise defined shall have the same meanings ascribed to them in the Original Schedule 13D.

Item 2. Identity and Background

This Amendment amends and restates the fourth paragraph of Item 2 of the Original Schedule 13D in its entirety as follows:

"The TPG Funds hold an aggregate of 16,492,334 Ordinary Shares (the "TPG Shares"). Because of the relationship between Group Advisors and each of the TPG Funds, Group Advisors may be deemed to beneficially own the TPG Shares."

Item 4. Purpose of Transaction

This Amendment amends Item 4 of the Original Schedule 13D by inserting the following before the paragraph titled "General":

"December 2013 Resale Offering

Pursuant to the Shareholders Agreement, on November 19, 2013, the Issuer filed a registration statement on Form S-1 (File No. 333-192417) (the "December 2013 Resale Registration Statement") to register 25,300,000 Ordinary Shares for resale by the Shareholders (the "December 2013 Resale Offering").

On December 4, 2013, the Issuer and the Shareholders entered into an underwriting agreement (the "December 2013 Resale Offering Underwriting Agreement") with UBS Securities LLC and Barclays Capital Inc. as Managing Underwriters and representatives of the underwriters named therein (the "December 2013 Resale Offering Underwriters"), pursuant to which, among other things, the TPG Funds agreed to sell, and the December 2013 Resale Offering Underwriters agreed to purchase, 2,750,000 Ordinary Shares at a price of \$32.1694 per Ordinary Share, which represents the public offering price of \$33.25 per Ordinary Share less the December 2013 Resale Offering Underwriters' discount of \$1.0806 per Ordinary Share. The TPG Funds also granted the December 2013 Resale Offering Underwriters a 30-day option to purchase up to an aggregate of 412,500 additional Ordinary Shares on the same terms.

The December 2013 Resale Offering closed on December 9, 2013.

December 2013 Resale Offering Lock-Up Agreement

In connection with the December 2013 Resale Offering, the TPG Funds agreed pursuant to a lock-up agreement (the "December 2013 Resale Offering Lock-Up Agreement"), subject to certain exceptions, not to, directly or indirectly, (i) sell, offer to sell, contract or agree to sell, hypothecate, pledge, grant any option to purchase or otherwise dispose of or agree to dispose of, or file (or participate in the filing of) a registration statement with the Commission in respect of, or establish or increase a put equivalent position or liquidate or decrease a call equivalent position within the meaning of Section 16 of the Exchange Act with respect to any of the Ordinary Shares, any other securities of the Issuer that are substantially similar to the Ordinary Shares, or any securities convertible into or exchangeable or exercisable for, or any warrants or other rights to purchase or subscribe for the foregoing, (ii) enter into any swap or other arrangement that transfers to another, in whole or in part, any of the economic consequences of ownership of Ordinary Shares or

any other securities of the Issuer that are substantially similar to Ordinary Shares, or any securities convertible into or exchangeable or exercisable for, or any warrants or other rights to purchase, the foregoing, whether any such transaction is to be settled by delivery of Ordinary Shares or such other securities, in cash or otherwise or (iii) publicly announce an intention to effect any transaction specified in clause (i) or (ii), for a period beginning on the date of such Lock-Up Agreement and continuing for 60 days after the date of

the December 2013 Resale Offering Underwriting Agreement (such period, the “December 2013 Resale Offering Lock-Up Period”), except with the prior written consent of the representatives of the underwriters.

The December 2013 Resale Offering Lock-Up Period will be automatically extended if (i) during the last 17 days of the December 2013 Resale Offering Lock-Up Period the Issuer issues an earnings release or announces material news or a material event or (ii) prior to the expiration of the December 2013 Resale Offering Lock-Up Period, the Issuer announces that it will release earnings results during the 16-day period following the last day of the December 2013 Resale Offering Lock-Up Period, in which case the restrictions will continue to apply until the expiration of the 18-day period beginning on the issuance of the earnings release or the announcement of the material news or material event, unless the underwriters agree to waive such extension.”

This Amendment amends and restates the last paragraph of Item 4 of the Original Schedule 13D in its entirety as set forth below:

“References to and descriptions of the Shareholders Agreement, the Lock-Up Agreement, the Resale Offering Underwriting Agreement, the Resale Offering Lock-Up Agreement, the December 2013 Resale Offering Underwriting Agreement and the December 2013 Resale Offering Lock-Up Agreement set forth above in this Item 4 do not purport to be complete and are qualified in their entirety by reference to the full text of the Shareholders Agreement, the Lock-Up Agreement, the Resale Offering Underwriting Agreement, the Resale Offering Lock-Up Agreement, the December 2013 Resale Offering Underwriting Agreement and the December 2013 Resale Offering Lock-Up Agreement, which have been filed as Exhibit 2, Exhibit 3, Exhibit 4, Exhibit 5, Exhibit 6 and Exhibit 7, respectively and are incorporated herein by this reference.”

Item 5. Interest in Securities of the Issuer

This Amendment amends and restates paragraphs 2 and 3 of Item 5 of the Original Schedule 13D as set forth below:

“(a)–(b) The following disclosure assumes that there are 205,145,258 Ordinary Shares outstanding as of November 15, 2013 as reported in the Final Prospectus filed by the Issuer with the Commission on December 4, 2013.

Pursuant to Rule 13d-3 of the Exchange Act, the Reporting Persons may be deemed to beneficially own 16,492,334 Ordinary Shares of the Issuer, which constitutes approximately 8.0% of the outstanding Ordinary Shares of the Issuer.”
