On September 14, 2018, Deckers Outdoor Corporation (the "Company") held its 2018 Annual Meeting of Stockholders (the "Annual Meeting"), virtually via live webcast at http://www.virtualshareholdermeeting.com/DECK, during which the Company's stockholders voted on three proposals. The Company had 30,368,803 shares of common stock outstanding on July 18, 2018, the record date for the Annual Meeting. At the Annual Meeting, 27,796,226 shares of common stock were present virtually or represented by proxy.

The following sets forth the final results of the voting for the three proposals voted upon at the Annual Meeting. These matters are described in more detail in the Company's definitive proxy statement on Schedule 14A, which the Company filed with the Securities and Exchange Commission on July 27, 2018 (the "Proxy Statement"). The stockholders elected ten candidates nominated by the Board of Directors of the Company to serve as directors of the Company until the annual meeting of stockholders to be held in 2019 or until their successors are elected and duly qualified.
