As previously announced, Dollar Tree Stores, Inc. has released a business update for its first quarter 2006, which is available via a recorded telephone announcement beginning April 6, 2006 after 5:00 PM EST and continuing through Monday, April 10, 2006. Thank you for calling the Dollar Tree business update hotline. This is Kent Kleeberger, Chief Financial Officer.

The information on this call about our future expectations, plans and prospects constitutes forward-looking statements under the Private Securities Litigation Reform Act of 1995. Our actual results may differ materially from those indicated by these forward-looking statements as a result of various important factors, including national and international events, consumer spending, and others described in our recent Annual Report, Current Report, and Quarterly Report on file with the SEC. This information is current only as of the date presented, and we will not update this information until our official quarterly sales release scheduled for Thursday, May 4, before market open.

Our previous sales guidance for the first quarter of fiscal year 2006, encompassing the reporting period of January 29, 2006 to April 29, 2006, was for total sales to be in the range of \$845 to \$870 million. As of April 6, the Company's sales may be characterized as in line with guidance, and we are therefore reaffirming that range.

As of April 6, 2006, Dollar Tree operated 3,100 stores in 48 states, including 2,962 Dollar Tree Stores and 138 Deal\$ stores, compared to 2,776 stores in 48 states at April 7, 2005.
