EXPLANATORY STATEMENT

QuadraMed Corporation (the “Registrant”) is filing this Post-Effective Amendment No. 1 to Registration Statement on Form S-8 filed on March 22, 2007 (File No. 333-141479) (the “Registration Statement”) to deregister certain shares of the Registrant’s common stock, par value \$0.01 per share (the “Common Stock”) that were registered for issuance pursuant to the Inducement Stock Option Agreement, effective October 17, 2005, by and between QuadraMed Corporation and Keith B. Hagen, the Restricted Stock Agreement, effective October 17, 2005, by and between QuadraMed Corporation and Keith B. Hagen, the Inducement Stock Option Agreement, effective August 1, 2005, by and between QuadraMed Corporation and James R. Klein, the Restricted Stock Agreement, effective August 1, 2005, by and between QuadraMed Corporation and James R. Klein and the Inducement Stock Option Agreement, effective November 21, 2005, by and between QuadraMed Corporation and Steven V. Russell (collectively, the “Plans”).

A total of 1,475,000 shares issuable to service providers of the Registrant pursuant to the Plans were registered under the Registration Statement. Subsequent to this registration, on June 13, 2008, the Registrant announced the effectiveness of the reverse split of its common stock in the ratio of one-for-five.

In connection with the Registrant’s filing of a Form 15 and suspension of duty to file reports under Sections 13 and 15(d) of the Securities Exchange Act of 1934, as amended, the Registration Statement is hereby amended to deregister any shares of Common Stock remaining unissued under the Plans.
