The investment in the DCSP operates similar to the SSP company stock fund, and the number of units will vary as the price of the Issuer's common stock varies.
- Between January 1, 2002 and September 30, 2002, the reporting person acquired 608 shares of International Paper common stock under the SSP. The information in this report is based on a plan statement dated as of September 30, 2002.
- Between January 1, 2002 and December 31, 2002, the reporting person acquired 5,117 shares of International Paper common stock under the Company's Dividend Reinvestment Program.
