**Digital return amount:** \$550 per security (representing a digital return equal to 55% of the stated principal amount).

**Buffer amount:** 25%

For each \$1,000 stated principal amount security you hold at maturity:

- If the final underlying value is **greater than or equal to** the initial underlying value: \$1,000 + the greater of (i) the digital return amount and (ii) \$1,000 × the underlying percent increase
- If the final underlying value is **less than** the initial underlying value by an amount **less than or equal to** the buffer amount: \$1,000

**Payment at Maturity:**

- If the final underlying value is **less than** the initial underlying value by an amount **greater than** the buffer amount: (\$1,000 × the underlying performance factor ) + \$250.00
