Issuer: Citigroup Global Markets Holdings Inc.

Underlyings: Dow Jones Industrial Average™, Russell 2000® Index and Nasdaq-100 Index®
Pricing date: October 31, 2018
Valuation dates: The last day of each month beginning in November 2018 and ending on October 31, 2023 (the “final valuation date”)
Maturity date: November 3, 2023
Contingent coupon payment dates: The fifth business day after each valuation date, except that the contingent coupon payment date following the final valuation date will be the maturity date 0.6% to 0.683% per month (7.2% to 8.2% per annum)*, **only if** the closing value of the worst performing underlying on the immediately preceding valuation date is greater than or equal to its coupon barrier value. **You are not assured of receiving any contingent coupon payments on the securities.**
Contingent coupon: If the closing value of the worst performing underlying on any potential autocall date is greater than or equal to its initial underlying value, the securities will be automatically redeemed on the immediately following contingent coupon payment date for an amount equal to the stated principal amount *plus* the related contingent coupon payment.
Automatic early redemption: Each valuation date in January, April, July, and October beginning in October 2019 and ending in July 2023
Potential autocall dates: For each underlying, 70% of its initial underlying value
Coupon barrier value: For each underlying, 60% of its initial underlying value
Final barrier value: If the securities are not automatically redeemed prior to maturity, you will receive at maturity for each security you then hold:
Payment at maturity (if the securities are not earlier automatically redeemed):

If the closing value of the worst performing underlying on the final valuation date is **greater than or equal to** its coupon barrier value:

\$1,000 *plus* the contingent coupon payment due at maturity

If the closing value of the worst performing underlying on the final valuation date is **less than** its coupon barrier value but **greater than or equal to** its final barrier value:
\$1,000

If the closing value of the worst performing underlying on the final valuation date is **less than** its final barrier value:

$\$1,000 + (\$1,000 \times \text{the underlying return of the worst performing underlying on the final valuation date})$

If the securities are not automatically redeemed prior to maturity and the closing value of the worst performing underlying on the final valuation date is less than its final barrier value, you will receive significantly less than the stated principal amount of your securities, and possibly nothing, at maturity, and you will not receive any contingent coupon payment at maturity.

Key Definitions

Initial underlying value: For each underlying, its closing value on the pricing date

Underlying return: For each underlying on any valuation date, (i) its closing value on that valuation date *minus* its initial underlying value, *divided by* (ii) its initial underlying value

Worst performing underlying: For any valuation date, the underlying with the lowest underlying return determined as of that valuation date

Selected Risk Considerations

- You may lose a significant portion or all of your investment. Unlike conventional debt securities, the securities do not provide for the repayment of the stated principal amount at maturity in all circumstances. If the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the closing value of the worst performing underlying on the final valuation date. If the closing value of the worst performing underlying on the final valuation date is less than its final barrier value, you will lose 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying has declined from its initial underlying value. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.
- You will not receive any contingent coupon on the contingent coupon payment date following any valuation date on which the closing value of the worst performing underlying on that valuation date is less than its coupon barrier value.
- The securities are subject to the risks of all of the underlyings and will be negatively affected if any of the underlyings perform poorly, even if the other underlyings perform well.

Whether the contingent coupon will be paid, whether the securities will be automatically redeemed and whether you are repaid your principal at maturity will depend on the closing values of the worst performing underlying solely on the applicable valuation dates.
