The pre-commencement communications filed under cover of this Schedule TO relate to a planned tender offer by THP Merger Co. (the <u>Purchaser</u>), a Delaware corporation and a wholly-owned subsidiary of Trinity Industries, Inc., a Delaware corporation (<u>Trinity</u>), to purchase all outstanding shares of Common Stock, \$0.01-2/3 par value per share (including the associated preferred stock purchase rights, the <u>Shares</u>), of Quixote Corporation, a Delaware corporation (<u>Quixote</u>), to be commenced pursuant to an Agreement and Plan of Merger, dated as of December 30, 2009, by and among Trinity, the Purchaser and Quixote.

Trinity, the Purchaser and Quixote intend to mail these documents to the stockholders of Quixote. These documents will contain important information about the tender offer, including the various terms of, and conditions to, the tender offer, and stockholders of Quixote are urged to read them carefully and in their entirety before making any decision to tender securities in the planned tender offer. When available, the Tender Offer Statement, as well as the Solicitation/Recommendation Statement, will be made available to Quixote s stockholders at no expense to them and will also be available at no charge on the SEC s website at www.sec.gov.
