Fir Tree Value Master Fund, LP, a Cayman Islands exempted limited partnership (Fir Tree Value), is the sole member of Sapling, and Fir Tree is the investment manager of both Sapling and Fir Tree Recovery.

Fir Tree may be deemed to beneficially own the shares of Common Stock held by Sapling and Fir Tree Recovery as a result of being the investment manager of Sapling and Fir Tree Recovery.
- (b) Sapling and Fir Tree Recovery are the beneficial owners of 4.6% and 1.2%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 2,355,000 shares of Common Stock which represent 5.8% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares beneficially held by 40,429,687 the number of shares of Common Stock issued and outstanding as reported in the Form 8-K filed by the issuer on February 8, 2007.
- (c) Sapling may direct the vote and disposition of 1,872,720 shares of Common Stock. Fir Tree Recovery may direct the vote and disposition of 482,280 shares of Common Stock. Fir Tree has been granted investment discretion over the shares of Common Stock held by Sapling and Recovery.
