We are unable to timely file our report on Form 10-K for the year ended December 31, 2006 (the Form 10-K) by the due date of April 2, 2007 without unreasonable effort or expense. The reasons therefore are set forth below.

We filed for protection under Chapter 11 of the United States Bankruptcy Code on February 7, 2007. We have been unable to obtain court approvals to engage independent accountants to perform an audit of our financial statements. Moreover, the hearings, filings and negotiations associated with bankruptcy have exhausted our limited staff resources for preparation of our financial statements and the Form 10-K.
